# Annual Report 2016-2017

## President's report

From our early beginnings in South East Queensland, the organisation that is now the Australian Smart Communities Association (ASCA) has grown in so many ways. We now are a truly national organisation which has evolved to represent cities, communities and a wider supply and service ecosystem. We partner with leading research organisations, national and international groups and state and federal governments.



In only seven years this volunteer organisation has developed into the mature organisation it is today. As this annual report is going to print, ASCA has employed its first CEO (Laurie Patton) and is well positioned to serve our communities and primary focus - the people of Australia.

During this past year, I am pleased to confirm that ASCA has again achieved its most successful year of growth and development. Thanks to our active network of members and partners, we have been able to increase our range and level of services and dynamically evolve the structure of the organisation to meet the changing needs and opportunities that present themselves.

- We held another successful Conference in Adelaide in May with almost 50 speakers, more than 300 delegates, a strong tradeshow and program of activities.
- We released our second *Guide to creating a smart community in Australia*.
- Partnered with the Australian Government to deliver 10 [Future Ready webinars](#) which attracted 1240 registrations.
- Our online seminars are growing in attendance and range of topics for our members.
- Our membership grew from 87 to 167 (92 percent increase).
- We launched a conference and ASCA events app.

As a not for profit organisation, we could not do all these things without the commitment and passion of our Board. We have developed a strong leadership group to ensure we provide high quality management of the organisation and planning for the future.

Behind our leadership group is a fantastic administration team. I would like to specifically acknowledge Megan (Administration Manager), Hari (Communications), Liz (Summit) and Christine (Future Ready webinars). Without these folks in the engine room, we would not be where we are today.

Finally, after seven years leading this organisation from the fledgling beginnings to the mature organisation with strong foundations for the future, I have decided to retire from the role of President and the Board. This will open the door for more renewal and further underpin ASCA's potential into the future.

I would like to thank you all for your support and alongside me continue to participate actively in ASCA as it sets forward into an increasingly digital future across Australia.



## Industry Board and Working Groups

ASCA established an [Industry Board](#) consisting of leading national and international organisations who are working together to establish collaborations with emerging smart cities and communities. Three [Working Groups](#) were also set up in March 2017 to bring together ASCA members to collaborate around solving some of the big challenges facing smart city adoption.

### Standards

#### *Terms of reference (purpose)*

ASCA seeks to support customers of smart city related technologies and systems to make wise choices regarding the selection of standards that underpin those technologies.

Common standards enable interoperability between devices and systems of different vendors, reducing implementation costs and increasing innovation efficiency. A nationwide approach endorsed by ASCA places Australian smart city customers in a good position to leverage national expertise and builds strong foundations for future development.

ASCA is not in a position to enforce standards. In practice smart city technology customers (eg councils) will specify standards they believe best meet their needs. We hope that such customers will refer to ASCA guidelines and recommendations for those standards.

#### *Key achievements and initiatives*

The Working Group has produced a terms of reference document which outlines our pragmatic approach to dealing with the complex field of smart city related standards. Our starting focus is city data models used to publish data such as lighting, bins, weather and air quality, in a machine-readable form.

We will also conduct a survey to help us discover exemplar projects from Australia and the world that might be using 'standards of interest' to Australia.

We are pleased to see Standards Australia showing an interest to facilitate ongoing coordinated standards activities.

## Funding and procurement

### *Terms of reference*

The purpose of the Working Group is to focus on the various alternatives available to cities looking to acquire funding for smart city projects. A major concern for city leaders is how they can afford smart technology. It might not be possible to reallocate funding for a new project, and it can take months, if not years, to get approval for new funding within a municipality.

The Working Group will research and provide a broad understanding of the options available to deliver critical funding for large and small projects. This could include structures such as public-private partnership (PPP), concession and other risk/reward models as well as more conventional models such as finance leasing. The Working Group will endeavour to identify current practices from around the world and highlight which models may be most appropriate for relevant smart city systems.

### *Key activities*

Working in collaboration with the Customer Liaison Group to identify and lay the groundwork with several local interested financing institutions and organisations. The working Group can only approach the potential funding organisation and government bodies once it understands who the user would be, what services we are talking about, costs and ROIs. This will be collated once potential end users have been identified, approached and services identified.



The 2017 conference was a great success for ASCA and smart communities across Australia.


